

# Kebu - Clear Skies remix contest

## Terms & Conditions

### Participation

- Entry to the contest is free and open to everyone worldwide.
- No payment or purchase is necessary to enter or win.
- Only one Remix (Contest Entry) per Participant can be submitted.

### Organizer

- The Organizers of the contest are Kebu / Sebastian Teir and ZYX Music GmbH & Co. KG.

### Modifications

- The Organizers may revise, change or alter the contest Terms & Conditions and/or cancel, modify or suspend the Remix Contest without prior notice in its sole discretion. Such changes will be made public on Kebu's website (<https://kebu.fi>) and on Kebu's other official social media channels.

### Eligibility

- Contest Entries can only be accepted for the song "Clear Skies" by Kebu. No other songs will be accepted.
- The Participants must be older than 18.

### Material Terms

- By submitting your Remix you warrant that all added content in the Remix is your own intellectual property, have been created by you and/or are royalty free loops/sounds.
- It is not allowed to use any third party content when entering the contest, except for royalty free loops/sounds.
- Kebu / Sebastian Teir will own all rights, title, and interest in and to your Contest Entry for the duration of the applicable copyright.
- All Contest Entries will be uploaded to Kebu's SoundCloud page and be placed in Kebu's playlist called "Clear Skies (REMIX CONTEST ENTRIES)". Entries will be added once a week, or at other intervals depending on Contest Entry submission activity, after the first Contest Entry has been received.
- After submitting, you may also upload your remix to your own social media pages, provided that the remix is titled as "Kebu – Clear Skies (# remix, contest entry)", with your name/artist name in

place of the "#". Monetization of the remix is not allowed. Kebu's partners may claim the remix for monetization on certain platforms (like Youtube)

- The parties agree that the winner(s) produced the Remix for Kebu / Sebastian Teir

### **Winner selection**

- When the entry closes, the winner will be selected by a panel of judges, consisting of Kebu as well as representatives from ZYX Music GmbH & Co. KG and 41065 Musikverlag/Backstage Promotion Veranstaltungs- und Verlags GmbH
- The panel may opt to select additional entries for 2nd and 3rd place.

### **Prizes**

- The winner will be granted 350 euro as a one-time fee (buy-out) and the winning Remix will be released on Kebu's upcoming "Clear Skies" single on ZYX Music.
- If additional entries are selected for release on the single, these entries will be granted 175 euro per remix.

### **Elimination**

- Any false information provided within the context of the contest by any participant concerning identity, mailing address, email address, ownership of right or non-compliance with these Terms & Conditions, will be directly eliminated from the remix contest and will not be allowed to participate again.
- Kebu and ZYX Music GmbH further reserve the right to disqualify any entry that they believe infringes upon or violates the rights of any third party, or the rights related to the song itself.

### **License Grant and Ownership**

- By entering this Contest, you agree that any intellectual property (including, without limitation, works of copyright) created in connection with the remix, will be wholly owned and controlled by Kebu / Sebastian Teir.
